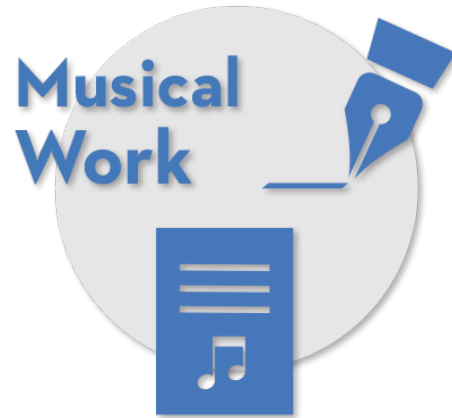

What's the difference
between a
“**musical work**” and a
“**sound recording**”?



A **musical work** is a work that consists of music (melody/rhythm/harmony) and any accompanying lyrics.

Examples:

- A song with music and lyrics
- An instrumental composition with music but no lyrics



A **sound recording** is a recording of a particular performance of a musical work.

“Respect” music and lyrics by Otis Redding

This is a musical work.

“Respect” performed by Otis Redding

“Respect” performed by Aretha Franklin

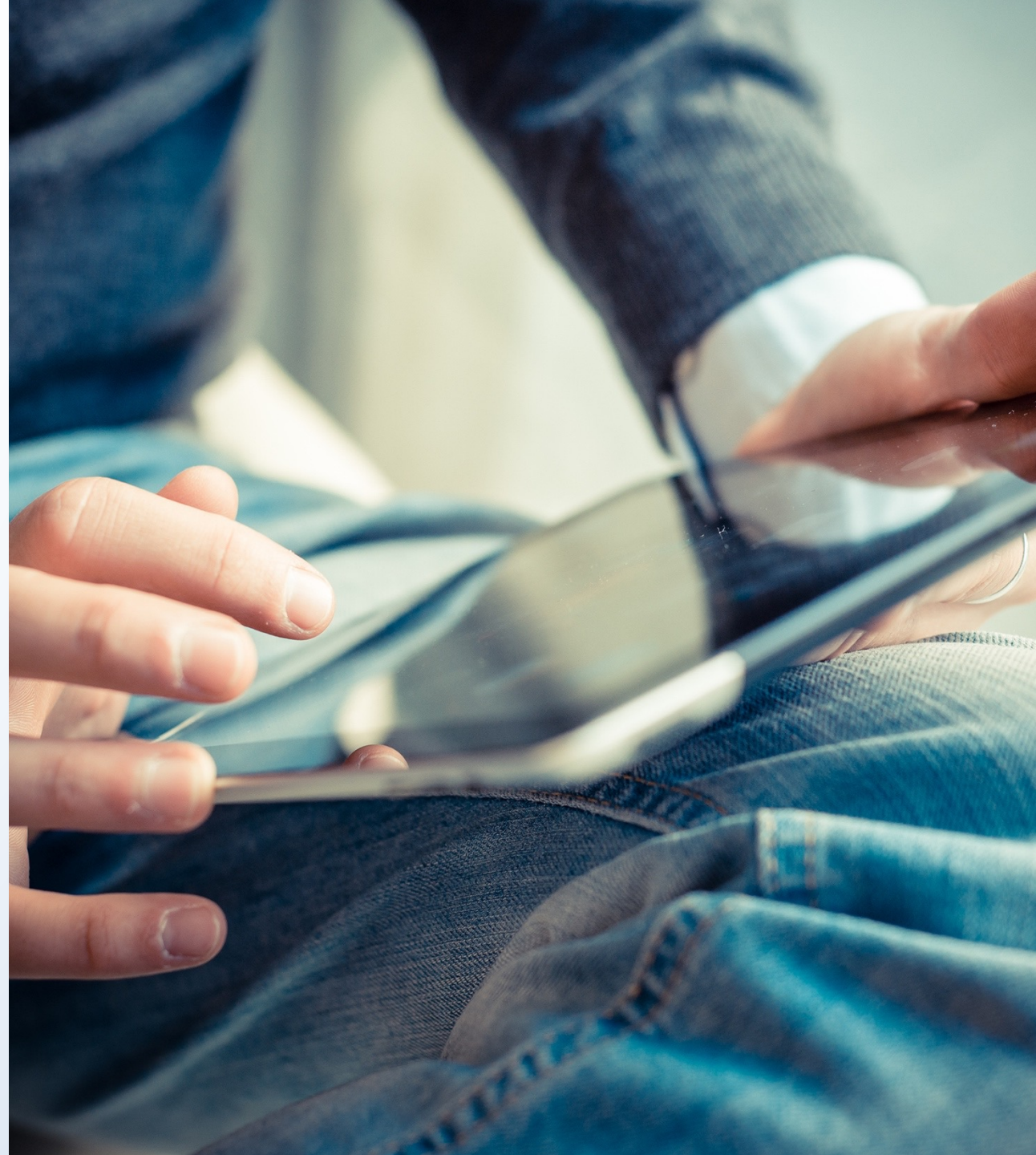
“Respect” performed by The Supremes and The Temptations

These are sound recordings.

Will applicants be able to register a **musical work** and a **sound recording** with the same group registration application?



What can be registered?

The application for **Musical Works from an Album** may be used to register musical works (with or without lyrics).

This application **cannot be used** to register the following types of works:

- Sound recordings
- Photographs
- Artwork
- Liner notes

The application for **Sound Recordings from an Album** may be used to register sound recordings.

This application may also be used to register the following types of works:

- Photographs
- Artwork
- Liner notes

The application for Sound Recordings from an Album **cannot be used** to register musical works (with or without lyrics).



Are there any other requirements that must be satisfied in order to use these group registration options?

Requirements

- ✓ You must submit **at least 2—but no more than 20**—musical works or sound recordings.
- ✓ All of the works being registered must be first published on the **same album**.

Note: There is a limited exception to this rule for works that were previously published as an individual work (such as a single) before they were published on the album. To learn more about this exception, go to this page for claims involving musical works: copyright.gov/eco/gram-pa/groups.html#previouslypublished, and go this page for claims involving sound recordings: copyright.gov/eco/gram-sr/groups.html#previouslypublished.

- ✓ They must be first published in the **same country**.
- ✓ And you must provide the **date and nation** of first publication for each work being registered.

Requirements

- ✓ You must provide the **title for the album** and a **title and track number** for each musical work or sound recording being registered.
- ✓ All of the works must be created by the **same author**, or the works must have a **common joint author**.

Note: The works may be registered as works made for hire if they are identified in the application as such.

The Copyright Office has developed a questionnaire that may be useful in determining whether a particular work qualifies as a “work made for hire.” To complete the questionnaire and to read more information about this topic, read **Circular 30**, copyright.gov/circs/circ30.pdf.

- ✓ Finally, the copyright claimant or co-claimants for all of the works must be the **same person** or the **same organization**.

You noted that the works must be created by the **same author**, or they must have a **common joint author**. What did you mean by that?



All of the works must be created by the **same author**
OR
All of the works must have a **common author**

Works Created by the Same Author

Works Being Registered	Author
Track 1	A
Track 2	A
Track 3	A

Works Created by the Same Co-authors

Works Being Registered	Co-authors
Track 4	A & B
Track 5	A & B
Track 6	A & B

Works Created by a Common Author

Works Being Registered	Co-authors
Track 1	A & B
Track 2	A & C
Track 3	A & D

A co-created tracks 1, 2, and 3.

A is the “common author” for each and every work in this group

Works Created by a Common Author

Works Being Registered	Co-authors
Track 4	A & B
Track 5	A & C
Track 6	D & E

A is the “common author” for tracks 4 and 5 because A co-created those works.

Track 6 doesn’t have a “common author” because the authors of that work (D & E) did not create the rest of the works in this group.



Now that we've discussed the authors of the works, tell us more about the copyright claimant.

Who is the copyright claimant?

The claimant is either

The author or co-authors of **all** of the works being registered

OR

The party that owns **all** of the exclusive rights that initially belonged to an author of **all** of the works being registered.



Do all of the works
need to have the
same claimant?



The copyright claimant for each work must be the **same person(s)** or the **same organization**.

A **third party** may be named as the copyright claimant(s) if that party owns **all** of the exclusive rights that initially belonged to an author of **all** of the works being registered.

Example:

Works Being Registered	Co-authors	Owner of All of the Authors' Exclusive Rights in the Works
Track 1	A & B	Company X
Track 2	A & C	Company X

Company X owns all of the exclusive rights that initially belonged to the authors of tracks 1 and 2. Company X may be named as the copyright claimant for those works.

Another example:

Works Being Registered	Co-authors	Owner of 50% of the Authors' Publishing Rights	Owner of All Other Exclusive Rights in the Works
Track 3	A & D	Company Y	A & D
Track 4	A & D	Company Y	A & D

Authors A & D may be named as the copyright claimant for tracks 3 and 4.

Company Y cannot be named as the copyright claimant, because the company does not own **all** of the exclusive rights that initially belonged to the co-authors of tracks 3 and 4.



Are there other requirements for using the GRAM option?



What about the
deposit requirements
for sound recordings?

Let's assume the album was published solely in a digital format.

The applicant plans to upload a digital copy of their musical works or their sound recordings.

Do the audio files need to be uploaded in a particular manner?



For a complete list of acceptable file formats that the Copyright Office, go to **copyright.gov/eco/help-file-types.html**.

The Office will **not accept**

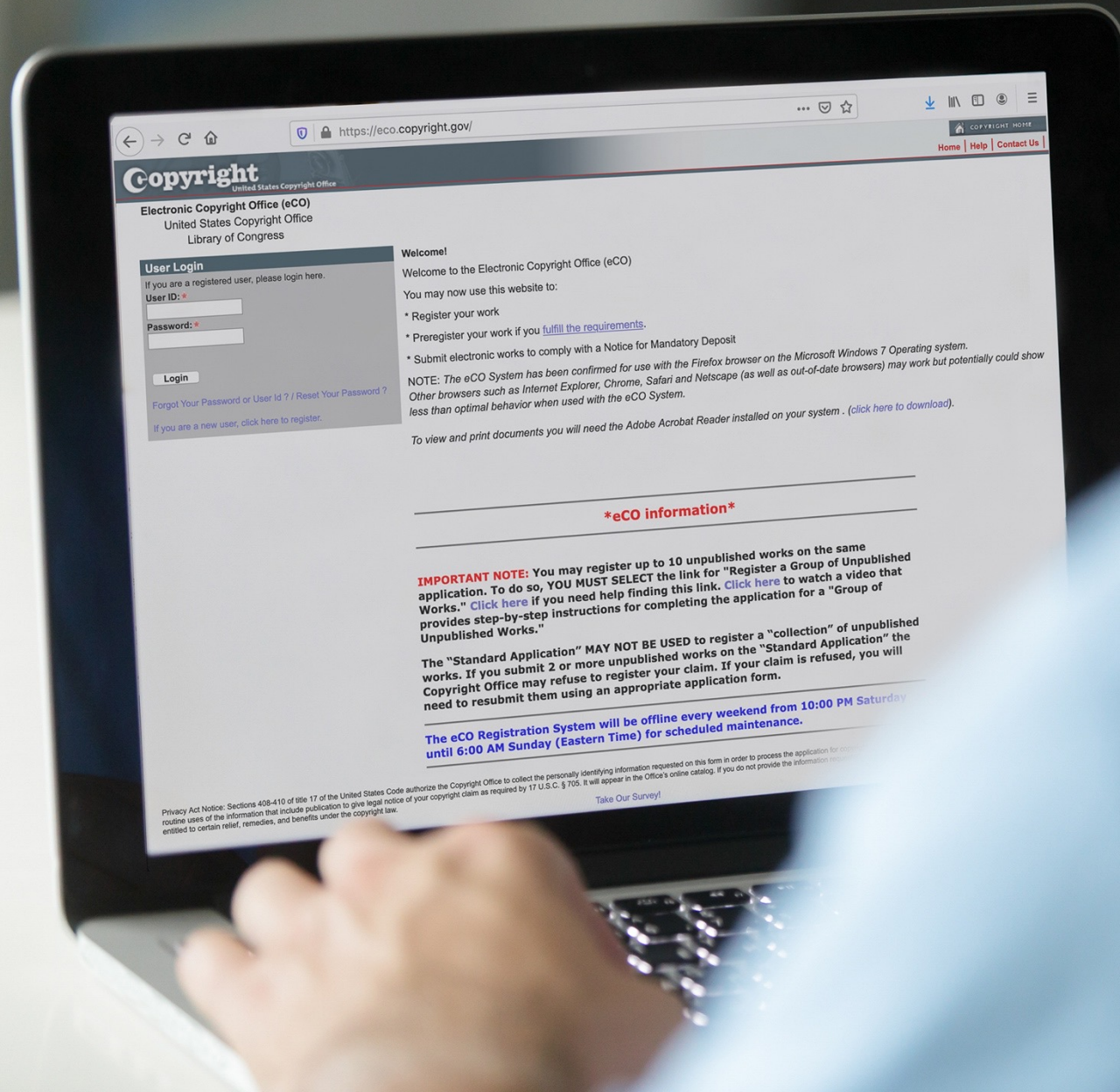
- Files containing multiple works
- Files uploaded in a single zip folder, instead of one-by-one
- Files submitted in an unacceptable file format



Filenames must match titles and track numbers.

Example:

Title listed in the application	Album track number listed in the application	Filename for the digital audio files
Birthday Party	2	02birthdayparty.mp3
Dinner Party	4	04dinnerparty.mp3
Wedding Party	6	06weddingparty.mp3
What's the Occasion?	12	12whatstheoccasion.mp3

These applications may **only** be used to register the types of works listed below.

If the Copyright Office determines that your works cannot be registered with these applications, your claim may be refused, or there may be delays in the examination of your claim that could require the payment of an additional fee and a later effective date of registration for your claim.

Group Registration Options

These applications may **only** be used to register the following types of works:

- Up to 3 months of issues from the same [serial publication](#)
- Up to 1 month of issues from the same [newspaper](#) or [newsletter](#) (regardless of whether the issues are published daily, weekly, bi-weekly, etc.)
- A group of [contributions](#) published in periodicals

- Up to 20 [musical works](#) published on the same album

The Copyright Office has implemented a new group registration option for musical works that are published on the same album.

In addition, the Office has implemented a separate group registration option for sound recordings and any accompanying photographs, artwork, or liner notes that are published on the same album.

Applicants are required to use a new registration application specifically designed for each option.

- **Musical works (with or without lyrics):** If you want to register a group of musical works (with or without lyrics), you must submit the online application for "[Musical Works from an Album](#)." This application can only be used to register musical works (including any lyrics). It cannot be used to register sound recordings. For instructions on how to access this application, [click here](#).
- **Sound recordings, photographs, artwork, liner notes:** If you want to register a group of sound recordings, you must submit the online application for "[Sound Recordings from an Album](#)." This application may be used to register two to twenty sound recordings. It may also be used to register photographs, artwork, or liner notes that were first published with the same album.
